The mission of Health and Environment Alliance

Founded in 2003, the Health and Environment Alliance (HEAL) is a leading European not-for-profit organisation addressing how the environment affects health in the European Union. Our organisation's vision is a healthy planet for healthier people in Europe and beyond. HEAL's advocacy and awareness-raising work aims to show how environmental action can bring down rates of asthma, obesity, diabetes, cancer and infertility.

Who may join HEAL

Membership to HEAL is open to non-governmental organisations and other not-for-profit organisations and professional bodies, whether local, regional, national, European or international. Applicants must be legally constituted pursuant to the laws and customs of their country of origin; have non profit-making purpose; and be independent of governments, political parties and commercial interests.

Three types of membership categories exist:

Full Members: Non-governmental organisations for which environment and health links are a major area of interest. Full members have two votes at the Annual General Assembly.

Associate Members: Other not-for-profit organisations and professional bodies, such as educational and academic institutions; professional associations; statutory and non-statutory environment or health agencies; and regional, city and local authorities. Associate members have one vote at the Annual General Assembly.

International Members: membership is open to organisations whose legal base is outside the 53 countries of the European region as defined by WHO. International members have observer status.

Membership Fee

The standard HEAL membership fee is **€300 per year** for full and associate members. For organisations from the Central and Eastern EU Member States the standard fee is **€100**.
