Project

Air pollution is the top environmental threat to health in the European Union and beyond, and there's a large body of evidence demonstrating the health harm, and cost. In recent years, more and more health organisations have become engaged on clean air policies, to prevent disease, lessen people's suffering and reduce healthcare cost.

At EU level, diverse Brussels-based health organisations have come together under the EU Healthy Air Coalition, coordinated by HEAL, to engage, communicate and advocate for clean air for health.

HEAL is looking to contract a web developer to design and develop a website for the Healthy Air Coalition.

This website aims towards building the Coalition's visibility and to make the case for EU clean air action to prevent disease.. The ultimate goals are to maximise the impact and relevance of the Healthy Air Coalition's outputs, to bring together and strengthen the voices of the Coalition members.

Deliverables

The deliverable is the Healthy Air Coalition's website.

- Main aim of the website: to ensure that the project's mission, the science and the advocacy activities are conveyed to the relevant audiences in ways that support the project's growth and success.

- The website should be developed in a way that allows for easy editing of existing sections and text. The back-end of the website should be structured in an intuitive, flexible and user-friendly way, to allow the HEAL team to make abovementioned changes without seeing IT support.
- The microsite should be build using Wordpress, to allow for easy incorporation within HEAL's main website hub.
- The microsite, as well as its development and launch, needs to comply with the requirements of the General Data Protection Regulation (GDPR), ensuring the processing, data security and data protection of data subjects when personal data are involved. It must also be in accordance with GDPR compliance of cookie policies.
- Basic structure and elements of the website: 1/ Home page; 2/About us; 3/ Policy change in Air quality legislation; 4/ Publications and resources; 5/ Latest news & events; 6/Contact u

Steps in the deliverable include:

- Initial meeting with the core team involved in this project;
- Website development proposal (including hosting options);
- Website mockups;
- A fully functional website by June 2024;
- Support with SEO;
- Support with setting up website analytics;
- A 'how-to' document to help navigate the back-end of the microsite.

Selection criteria

We are looking for someone who meets the following criteria:

- Expertise in the design and development of websites for civil society organisations
- Respondents should provide outlines of the costs and expected timelines for delivery of the project.
- The maximum budget 10,000 EUR (VAT incl), this includes the delivery of the website by June 2024 as well as the provision of an hourly rate for future ad hoc interventions of the developer in the second half of 2024, and 2025.

Terms and conditions

The contract will be awarded for work carried out between April and June 2024.

Contract signature is expected for mid April.
